

With reference to the above Letter no -LIMRA/GTX-ML-1/2017 Dated 09 May 2017 of LIMRA Trade Fairs & Exhibitions (Pvt) Ltd, Dhaka the undersigned is directed to convey the permission of the Ministry of Commerce for organizing the exhibition title (1) "GarTex Bangladesh Expo" (2) "Bangladesh Leather & Footwear Expo" and (3) "Print Tech Bangladesh" to be held at International Convention City, Basundhara, (ICCB) ,Dhaka, Bangladesh, from 20-22 July 2017 under the following terms and conditions:

- e) The organizer should inform the law and order authority for organizing exhibition;
- f) The Ministry of Commerce reserves all rights to alter/change/cancel this permission at any time without assigning any reason.
