- World Intellectual Property Organization (WIPO) Scholarship will bear all costs of the regarding Master Course. The Government of Bangladesh (GoB) will have no financial involvement in this regard;
- He will depart Dhaka for Australia on 26 February 2017 or any suitable date close to that and depart Australia for Dhaka on 28 October 2017 or any suitable date close to that after completion of the said course. He will not be allowed to stay in abroad more than the approved period;
- He will submit a report to the Senior Secretary, Ministry of Commerce with a copy to Hon'ble Minister, Ministry of Commerce within 10 working days upon his return from Australia after completion of the course.
