- d) They will stay in USA from 15-20 July 2017 (excluding travel time). They will not be allowed to stay abroad more than the approved period;
- e) They will submit a report on the said Fair to the Secretary, Ministry of Commerce with a copy to Hon'ble Minister, Ministry of Commerce within 10 working days after their return from USA.
