Subject: Government Order for Mr. Rathindra Nath Datta, Deputy Secretary, Ministry of Commerce for attending the "Thailand Consortium on Trade Control on Weapons of Mass Destruction Related Items (TCWMD)" to be held in Thailand during 18-19 July 2017.

The undersigned is directed to convey the sanction of the Government of the People's Republic of Bangladesh to **Mr. Rathindra Nath Datta, Deputy Secretary, Ministry of Commerce, Bangladesh Secretariat** to attend the "Thailand Consortium on Trade Control on Weapons of Mass Destruction Related Items (TCWMD)" to be held in Thailand during 18-19 July 2017 under following terms and conditions:

- (a) While on visit he will be treated as on duty;
- (b) He will draw his pay and allowances in local currency. No part of it shall be drawn in foreign currency;
- (c) All expenses will be borne by the organizer of the said program. No part of it will be borne by the Government of Bangladesh (GoB) in this regard;
- (d) He will depart Dhaka for Thailand on 17 July 2017 or any suitable date close to that and depart Thailand for Dhaka on 20 July 2017 or any suitable date close to that after completion of the said program. He will not be allowed to stay abroad more than the approved period;

02. This Government Order (G.O) is issued in the public interest and with the approval of the competent authority.


