- He will depart Dhaka for Sweden on 12 February 2017 or any suitable date close to that and depart Sweden for Dhaka on 18 February 2017 or any suitable date close to that after completion of the said course. He will not be allowed to stay in abroad more than the approved period;
- He will submit a report on the said course to the Senior Secretary, Ministry of Commerce with a copy to Hon'ble Minister, Ministry of Commerce within 10 working days upon his return from Sweden.


