- They will stay in Frankfurt, Germany from 08-14 January 2017 (excluding travel time). They will not be allowed to stay abroad more than the approved period;
- They will submit a report on the said fair to the Senior Secretary, Ministry of Commerce with a copy to Hon'ble Minister, Ministry of Commerce within 10 working days after their return from Germany.
