- (d) He will depart from Dhaka for China on 11 June 2017 or any suitable date close to that and leave China for Dhaka on 15 June 2017 or any suitable date close to that. He will not be allowed to stay abroad more than the approved period;
- (e) He will submit a report on the said Program to the Secretary, Ministry of Commerce within 07 working days after completion of the visit.
