- They will submit a report on the said fair to the Secretary, Ministry of Commerce with a copy to Hon'ble Minister, Ministry of Commerce within 10 working days after their return from New Delhi, India;

02. This Government Order (G.O) is issued in the public interest and with the approval of the competent authority.


