- (d) All expenses of Mr. Md. Saiful Islam, PS to Hon'ble Commerce Minister, Ministry of Commerce will be borne by the Ministry of Commerce from the budget allocated for the travel expenses;
- (e) The Hon'ble Minister will depart Dhaka for Bangkok, Thailand on 28 August 2017 or any suitable date close to that after that he will depart for Colombo, Sri Lanka and depart Sri Lanka for Dhaka on 03 September 2017 or any suitable date close to that;
- (f) Mr. Md. Saiful Islam, PS to Hon'ble Commerce Minister will depart Dhaka for Colombo, Sri Lanka on 29 August 2017 or any suitable date close to that and depart Sri Lanka for Dhaka on 03 September 2017 or any suitable date close to that;


