- (d) They will stay in Belgium from 23-28 April 2017 (excluding travel time). They will not be allowed to stay abroad more than the approved period;
- (e) They will submit a report on the said fair to the Secretary, Ministry of Commerce with a copy to Hon'ble Minister, Ministry of Commerce within 10 working days upon their return from Belgium.

02. This Government Order (G.O) is issued in the public interest and with the approval of the competent authority.


