- (d) He will depart Dhaka for Boston, USA on 02 June 2017 or any suitable date close to that and depart Boston, USA for Dhaka on 08 June 2017 or any suitable date close to that. He will not be allowed to stay in abroad more than the approved period;
- (e) He will submit a report on the above mentioned Conference to the Secretary, Ministry of Commerce with a copy to Hon'ble Minister, Ministry of Commerce within 10 working days after his return from Boston, USA.

02. This Government Order (G.O) is issued in the public interest and with the approval of the competent authority.


