**Terms and conditions:**

- (a) While on Meeting he will be treated as on duty;
  - (b) He will draw his pay and allowances in local currency. No part of it will be drawn in foreign currency;
  - (c) South Korean authority will bear the cost of air ticket and accommodation. Daily allowances will be borne by the Government of Bangladesh in this regard;
  - (d) He will depart Dhaka for South Korea on 27 April 2017 or any suitable date close to that and depart South Korea for Dhaka on 29 April 2017 or any suitable date close to that after completion of the said Meeting. He will not be allowed to stay in abroad more than the approved period;
  - (e) He will submit a report on the said Meeting to the Secretary, Ministry of Commerce with a copy to Hon'ble Minister, Ministry of Commerce within 10 working days after his return from South Korea.
02. This Government Order (G.O) is issued in the public interest and with the approval of the competent authority.


