Subject: Government Order for participation in the training titled "Advanced Trade Policy Course 2017-2018" to be held in Stockholm, Sweden during 16-27 October 2017.

The undersigned is directed to convey the sanction of the Government of the People's Republic of Bangladesh to Mr. S. M. Masudur Rahman, Deputy Secretary and Mst Shamima Akter, Assistant Chief, Ministry of Commerce, Bangladesh Secretariat, Dhaka for participation in the training titled "Advanced Trade Policy Course 2017-2018" to be held in Stockholm, Sweden during 16-27 October 2017 under following terms and conditions:

- (a) The period of participation in the aforesaid training and time spent for travel and transit will be treated as on duty;
- (b) They will draw their pay and allowances in local currency. No part of it shall be drawn in foreign currency;
- (c) The National Board of Trade, Sweden will bear all expenses and there will have no financial involvement of The Government of Bangladesh (GoB) in this regard;
- (d) They will depart Dhaka for Sweden on 15 October 2017 or any suitable date close to that and depart Sweden for Dhaka on 28 October 2017 or any suitable date close to that after completion of the aforesaid training. They will not be allowed to stay in abroad more than the approved period;
- (e) They will submit a report on the training to the Secretary, Ministry of Commerce with a copy to Hon'ble Minister, Ministry of Commerce within 10 working days upon their return from Sweden.
