- (e) They will submit a report on the said fair to the Secretary, Ministry of Commerce with a copy to Hon'ble Minister, Ministry of Commerce within 10 working days upon their return from Dubai.

02. This Government Order (G.O) is issued in the public interest and with the approval of the competent authority.


