- (d) He will depart Dhaka for Bhutan on 13 June 2017 or any suitable date close to that and depart Bhutan for Dhaka on 16 June 2017 or any suitable date close to that after completion of the said meeting. He will not be allowed to stay in abroad more than the approved period;
- (e) He will submit a report on the said meeting to the Secretary, Ministry of Commerce with a copy to Hon'ble Minister, Ministry of Commerce within 10 working days after his return from Turkey.


