**Terms and conditions:**

  - (b) They will draw their pay and allowances in local currency. No part of it shall be drawn in foreign currency;
  - (c) Korea International Cooperation Agency (KOICA) will bear all costs of the regarding fellowship program. The Government of Bangladesh (GoB) will have no financial involvement in this regard;
  - (d) They will depart Dhaka for Korea on 26 October 2016 or any suitable date close to that and depart Korea for Dhaka on 10 November 2016 or any suitable date close to that after completion of the said fellowship program. They will not be allowed to stay in Korea more than the approved period;
  - (e) They will submit a report on the said fellowship program to the Senior Secretary, Ministry of Commerce with a copy to Hon'ble Minister, Ministry of Commerce within 10 working days after their return from Korea.
