- (d) They will stay in Tokyo, Japan from 05-10 November 2016 (excluding travel time). They will not be allowed to stay abroad more than the approved period;
- (e) They will submit a report on the said fair to the Senior Secretary, Ministry of Commerce with a copy to Hon'ble Minister, Ministry of Commerce within 10 working days after their return from Japan.
