 - (d) They will depart Dhaka for India on 06 November 2016 or any suitable date close to that and depart India for Dhaka on 26 November 2016 or any suitable date close to that after completion of the said training. They will not be allowed to stay in abroad more than the approved period;
 - (e) They will submit a report on the said training course to the Senior Secretary, Ministry of Commerce with a copy to Hon'ble Minister, Ministry of Commerce within 10 working days after their return from India.
